

## PQRS Corner

### Four Weeks to Go!

If you're planning to submit your 2015 PQRS data via **EHR** (direct or data submission vendor) or a **qualified clinical data registry** (QCDR), the deadline is **February 29 at 8 pm** ET.

Other key reporting deadlines:

- **March 11** for **GPRO Web Interface**
- **March 31** for **Qualified registries (Registry XML) & QCDR (QCDR XML)**



Not reporting your 2015 PQRS data will result in an automatic **-2.0%** PQRS payment adjustment to your Medicare Part B payments in 2017.

It will also trigger an additional **-2.0%** Value Modifier (VM) payment adjustment to your 2017 Medicare payments.

An [Enterprise Identity Management \(EIDM\)](#) account is required for these PQRS data submission methods.
