What Can the Legislature Do?

Increase Practice Sustainability

- Create payment models that increase access to primary care (H. 185 with modifications)
- Update Worker's Compensation Fee Schedule for first time since 2006
- Ensure that federal Rural Health Transformation fund and AHEAD Model support all practice types
- Sustain Vermont's high rates of insurance coverage and adequate Medicaid fee schedule

Reduce Administrative Burden

- Allow recording of telehealth appointments with consent (H. 84)
- Enact comprehensive data privacy protections aligned with HIPAA (S. 71)
- Monitor implementation of prior authorization reductions and billing simplification (Act 111 of 2024)

Ensure A Strong Workforce

- Fund establishment of Maple Mountain Family Medicine residency program
- Ensure funding for VT AHEC primary care scholarship & AHEC loan repayment
- Prohibit corporate interference in the practice of medicine (H. 71 with modifications)
- Prohibit covenants not to compete in healthcare (H. 205 with modifications)
- Sustain embedded mental health services including Blueprint Mental Health Integration and Vermont Consultation and Psychiatry Access Program

Support Public Health

- Maintain access to all vaccinations including COVID-19
- Protect access to reproductive services and gender-affirming care
- Ban sale of flavored tobacco products
- Maintain strong cannabis potency and advertising regulations
- Adequately fund substance use prevention programs



VMS Organization

VMS is made up of 3100 members, including PAs, medical students, residents and approximately 2/3 of practicing physicians in Vermont. Our members represent primary care, specialists, and all employer- types (hospital-employed, FQHC, independent practice). www.vtmd.org
