LOGISTICS

Parking Options:

- On-street parking 2-hr parking in spaces around the Statehouse for \$1per hr. Download the Parkmobile app to avoid parking tickets
- <u>Capitol City Parking Lots</u> long-term parking behind the Capitol Plaza Hotel for \$0.75 per hr.
- Vermont Department of Labor Free parking is offered at the lot at the Vermont Department of Labor (<u>5 Green Mountain Drive</u>). You can park and walk to the Statehouse via the bike path.





Where am I going?

- walk in the side door on the Gov. Davis Ave side of the building. Bring your license or other ID and security will give you a badge to go to the 4th floor office. We will meet here at 2pm.
- <u>Google Directions</u> to the Statehouse no ID necessary and you don't have to go through a scanner. The cafeteria is on the 2nd floor, go to room N on the map. We will meet here at 3pm and 4pm.

VMS 2023 POLICY PRIORITIES

Increase Practice Sustainability

- Fund adequate Medicaid, private payer, and Blueprint investment in primary care
- Ensure pay parity for audio-only telehealth services
- Update the Worker's Compensation Fee Schedule

Reduce Administrative Burden

• Reduce/streamline the prior authorization approval process

Ensure Strong
Workforce

- Provide ongoing funding for primary care scholarships, loan repayment, residency programs
- Reduce workplace violence against healthcare workers
- Meet statewide economic development needs like housing & childcare

Support Public Health

- Ensure adequate substance use prevention policies and funding
- Support legal protections for providers of reproductive health care services
- Increase pediatric and adult mental health care services

- Track a bill
- Participate in VMS Advocacy Alerts via the VMS Rounds Newsletter & VMS Legislative Bulletin
- Contact your legislator and/or members of key legislative committees following the bill to express your opinion.
- You can reach legislators by emailing them, calling their home phone, or by leaving a message at the Statehouse by calling (802) 828-2228.
- Write a letter to the editor of your hometown newspaper.
- Inform VMS of your willingness to testify before legislative and policy committees or to visit the statehouse to lobby lawmakers in person.

Gun Violence Prevention Package 72-hr waiting period Ban on under 21 possessing

- semiautomatic weapons



Childcare Funding

- Comprehensive systemPotential Payroll Tax





Cannabis Regulation

- Remove potency limits
- Remove 92% tax on cannabis vapes
- Door to door sales



Provider "Shield" Law

- Protect providers who perform abortion services from extradition
- Protect providers who perform gender-affirming care from extradition



Forensic Mental Health Facility

- Physical site
- Competency Restoration



Flavored Tobacco Ban

- Bans all flavored tobacco products, including vapes
- Ban includes menthal products



Workplace Violence Bill

Warrantless arrest for violence in a health care setting

FRAME Your Message:

Start by Framing Your Message*

People, Pocketbooks, and Principles: In the current circumstance, what does your audience care most about? Which frame aligns your message with their values?

A framing statement can often be crafted by completing one of the following sentences with your audience in mind: "We can all agree that..." or "We all benefit when..."

For example: We all benefit when our youth are as healthy as possible."





CRAFT Your Message:

These questions can help define your message:

Problem: What is the problem today?

For example: Youth are addicted to nicotine via vapes.

Solution: What is the solution/the proposed fix? Provide a personal story or experience to better illustrate why your solution is critically necessary to address the problem. For example: By passing the flavor ban, youth will not start using these highly-addictive products.

Action: What is your ask or call-to-action? For example: Pass the bill prohibiting the sale of flavored tobacco products including menthol.
